- 1. Complete this application (attach additional sheets if necessary). Your name and address should be on all attachments. Completeness and neatness ensure your application will be evaluated appropriately.
- 2. Recent academic transcript whether it be from a high school, college, university, or trade school.  
CURRENT COLLEGE FRESHMAN - Judges will screen and require more than one semester or quarter of grades. If this applies to you, submit your high school transcript.
- 3. Copy of your college entrance examination (ACT *and/or* SAT) scores. (College Freshman Only.)
- 4. **Essay** – Describe how a cooperative can build a culture to best serve its members.
- 5. Applicant Appraisal.
- 6. Mail your complete application packet as directed below.
  - If you are a dependent child of a member cooperative consumer, or a child of a member cooperative employee, **send this application and all supporting documentation to Mor-Gran-Sou Electric Cooperative, Inc.** (Each member cooperative will be responsible for selecting finalists in these categories.)
