Annual Meeting rescheduled for Aug. 20, 2 p.m. CT on BEK TV

Due to the COVID-19 emergency declaration and limitations on public gatherings, the Mor-Gran-Sou board of directors has decided for the safety of its members to reschedule the 2020 Annual Meeting as a virtual meeting, which will be televised on BEK TV on Aug. 20 at 2 p.m. CT. All voting for this year's Annual Meeting will take place by mail, as permitted by your cooperative's bylaws and policies. The voting will include the election of the board of director positions for Grant County, Sioux County and Mandan Area.

Mor-Gran-Sou announces candidates seeking board of director positions

he pursuit to earn a board seat begins for five Mor-Gran-Sou Electric Cooperative members vying for one of three board director positions up for re-election. The three board positions sought include: one for the Grant County position, one for the Mandan-Area position, and one for the Sioux County position.

The board of directors set March 10 as the deadline for receiving members' completed declaration of candidacy forms. The Nominating Committee met for a final time on March 19. At that meeting, the committee declared that the candidates' names they received be forwarded to the board of directors for approval. Upon confirmation of eligibility at its regular board meeting on March 25, the Mor-Gran-Sou board of directors approved the following list of candidates:

Pole testing scheduled

or-Gran-Sou began annual pole testing in May, starting in Morton County north of the Cannonball River near Solen. When work in the north area is complete, ending around Huff, testing will continue in Sioux County, working from Solen south to the South Dakota border.

The inspection consists of team members accessing all cooperative distribution lines using four-wheelers, and testing each pole for rot or other damage.

For your safety and theirs, do not approach the pole testing crew. We wish to be prudent and continue practicing social distancing.

We thank our members for their understanding as we work to make the system as reliable as possible.

Keeping our electric system as reliable as possible

Tree trimming and tree removal in the right-ofway is a regular part of your electric cooperative's operations. Mor-Gran-Sou, like all electric utilities, is required to maintain appropriate clearance between trees and electric transmission and distribution lines. Trees need to be trimmed, and in some cases removed, to minimize potential power blinks and outages, and to eliminate fire and safety hazards due to trees contacting energized electric lines.

Mor-Gran-Sou will have crews operating within our service area starting in June. Work will occur system-wide.

The tree-trimming crews are working on your cooperative's behalf to help keep our electric system as reliable and safe as possible. ■

Sign up to receive text messages

Innovation is a core value at Mor-Gran-Sou Electric Cooperative, Inc. As advancing technologies become available, we utilize them to benefit our membership.

One of the communication tools offered by SmartHub is text messaging. These timely messages would alert our members to planned power outages, billing information, upcoming events and other important notices.

Please sign up for this additional communications tool!

To sign up through SmartHub, follow these steps:

Website instructions at www.morgransou.com:

- 1. Log onto SmartHub by clicking My Account, upper right-hand corner of home page. Find notifications on the blue header.
- 2. Hover over notifications; choose manage contacts. A box will appear. Find your mobile phone number; click edit. If your mobile phone number does not appear, please add it.
- 3. A "contact settings" window appears. Click the box that says receive text messages. A black check mark indicates you will receive text messages.
- 4. **Manage other notifications.** Return to the blue header; find notifications. Hover over notifications and select manage notifications. A screen will appear with categories for billing or miscellaneous. Click a category; there are many notification types under each category.
- 5. For each notification type, choose if you would like to be notified by email or text or both. Save your settings. Do this for both categories if you wish.



Cell phone or tablet instructions:

- 1. Log onto SmartHub. For cell phone: Click more at the bottom of the screen. Next click settings; then click contact methods. For tablet: Click settings at the bottom of the screen. Next click contact methods.
- 2. Find your mobile phone number and click the right arrow.
- 3. An "add or edit phone contact" window appears. Move the slide to confirm. The colored slide indicates you will receive text messages.
- 4. **Manage other notifications.** Return to settings. Select manage notifications. A screen will appear with categories for billing, miscellaneous and service. Click a category; there are many notification types under each category.
- 5. Follow step five listed on the previous page in website instructions.

* If you are entering your phone number for the first time, you may need to accept Text Terms and Conditions. Once you accept, a verification code will be sent via text. Enter the code to finalize your enrollment.

Please check your phone plan to ensure your plan has unlimited texting. Some plans bill the recipient for each text message received, and we don't want to cause a financial hardship.

You will not be able to reply or text the cooperative. This tool is only set up for Mor-Gran-Sou to send, and not receive, messages.
