# Members receive NDSU Harvest Bowl honor

At Mor-Gran-Sou Electric Cooperative, we are constantly striving to improve our operational efficiency, so we can provide the most reliable electric service possible for our consumer-members (that's you!).

We rely on data for nearly every aspect of our operations, which is why we need your

help. By making sure we have your most accurate and complete contact information, we can continue to provide the high level of service you expect and deserve. Accurate information enables us to improve customer service and enhance communications for reporting and repairing outages. It also allows co-op members to receive information about other important programs, events and activities.

Up-to-date contact information can potentially speed up the power restoration process during an outage. For example, the phone number you provide is linked to your service address in our outage management system. This means when you call to report an outage, our system recognizes your phone number and matches it with your account location. Accurate information helps our outage management system predict the location and possible cause of an outage, making it easier for our crews to correct the problem.

While we always do our best to maintain service, we occasionally plan outages to update, repair or replace equipment. In these instances, we can provide advance notification to affected members through automated phone messages if we have your updated contact information and communication preferences.

Keeping the co-op updated with your information also helps us when there's a question about energy use or billing. Emails and text messages are also used to notify registered members of any changes in co-op event details. In addition, discrepancies on your account can be taken care of promptly if Mor-Gran-Sou Electric has accurate account information.

Many of you have been members of the co-op for years, and it's likely your account information hasn't been updated for some time. We recognize many members now use a cellphone as their primary phone service, and we might not have that number in our system.

I want to emphasize we will never share your contact information with any third parties. It is only used by Mor-Gran-Sou Electric to send important information to you. By doing so, you will be helping us improve service and efficiency so we can better serve you and all members of the co-op.

## Safety Starts with ME: Julie Armijo

Power surges can be frustrating, but typically happen unexpectedly. To reduce the members' risk of damage, it is important to be knowledgeable and prepare ahead of time if and when a power surge does strike.

"A power surge is typically caused by lightning, changes in electrical loads, faulty wiring or damaged power lines," said Julie Armijo, Mor-Gran-Sou Electric Cooperative's member services manager. "Regardless of the cause, a power surge can cause significant damage to electronic devices and equipment in your home."

#### **Common causes**

Electrical overload happens when devices or appliances are plugged into an outlet that cannot handle that amount of voltage, or if multiple devices are plugged in at the same time through an extension cord. Please contact Mor-Gran-Sou Electric if you are experiencing recurring power surges or frequent interruptions in power.

Faulty wiring in a home is another cause of power surges. Signs of a faulty wire include visible burns on outlets, buzzing sounds from outlets or frequently tripped circuit breakers.

"If you notice these signs, it may be time for an electrical wiring repair or update," Armijo said.

A quick surge of electricity may also occur after Mor-Gran-Sou Electric restores the power after an outage. In the case of a power outage, it is important to unplug any sensitive devices around your home, then wait to plug them back in after power is restored.

#### Protect electronics in your home

There are two other ways in which you can save the longevity of devices in your home.

Point-of-use surge protection devices can protect your devices during most power surges. Not all power strips, however, include surge protection. So, before buying a power strip, read the packaging and do not overload the power strip with too many devices.

Whole-home surge protection can protect your home from more powerful power surges. These are connected to your home's service panel and include features like thermal fuses



and notification capabilities to inform when a device has been impacted by a surge. The price of this device varies and should be connected by a licensed electrician.

**Energy Efficiency Tip of the Month** 



Washing windows and screens is a great way to practice energy efficiency during spring cleaning. Clean windows and screens make your home brighter by allowing more sunlight in, reducing the need for lamps and fixtures.

Clean screens also allow more fresh air in the home when the windows are open to recycle indoor air. Natural light and clean air are energy savers, and they enhance overall health and productivity.



### Mor-Gran-Sou's annual meeting scheduled for July 21

Are you looking for a way to serve the people of central southwestern North Dakota? Look no further, as Mor-Gran-Sou Electric Cooperative can help you fulfill that desire. Why not serve as a board director for the cooperative?

The initial commitment is a three-year term, with provisions in the bylaws limiting a director to serving six consecutive three-year terms, after which time the director is not eligible for another six consecutive three-year terms until one year has elapsed.

At the annual meeting, the following three board positions will be elected:

- The Grant County position presently held by Casey Wells (currently serving his fifth threeyear term)
- The Mandan area position presently held by Bob Leingang (currently serving his fifth threeyear term)
- The Sioux County position presently held by Rodney Froelich (currently serving his first three-year term)

Under the bylaws and due to the use of a mailin ballot, no nominations are accepted from the floor at the annual meeting. Instead, the bylaws require the board of directors to appoint a Nominating Committee of five to nine members who geographically represent the cooperative. These members will provide a list of qualified and willing candidates to the board for approval and inclusion on the ballot at the board of directors' meeting scheduled for March 29. This date has been set so there is adequate time for each candidate's biographical information to be included with the notice of meeting sent to the members in June, along with the mail-in ballot for those who are unable to attend the annual

meeting in person.

The Nominating Committee has been appointed by the board and met for the first time on Jan. 10. The members of the Nominating Committee include Jennifer Bonogofsky, St. Anthony; Jackie Buckley, Mandan; Rosie Erhardt, Mandan; Glenda Gross, Selfridge; Garek Murphy, Fort Yates; Jim Neubauer, Mandan; Toby Olin, New Salem; Donald D. Roth, New Leipzig; and Yvonne Seidler, New Leipzig.

For a person to be nominated, the member vying for a board seat must submit the completed declaration of candidacy form to Mor-Gran-Sou by 4 p.m. CT (3 p.m. MT) on Thursday, March 16. The completed form must be mailed to Mor-Gran-Sou Electric Cooperative, Attn: Julie Armijo, P.O. Box 1090, Mandan, ND 58554-7090.

## Need help with your energy bills? **LIHEAP is here to help**

While the winter weather continues, Mor-Gran-Sou Electric Cooperative members will be faced with colder temperatures. For some, anticipation of the winter months causes stress and anxiety, as they wonder how to make ends meet. Thankfully, there are programs to help members.

Thankfully, there are programs to help members
The Low-Income Heating Energy Assistance

Program, also known as LIHEAP, can help Mor-Gran-Sou's low-income and eligible individuals with assistance when it comes to heating and insulation costs in the winter. Through the North

Human Services, human service zone offices and Community Options, individuals can be helped with a variety of services when it comes to heating assistance.

Dakota Department of



LIHEAP offers a variety of service assistance. Not only can the program help curve the costs of your heating and cooling bill, but it also helps households with weatherization, which helps make homes more energy efficient.

"For example, if someone lives

in a 100-year-old home, with outdated windows, we might be able to help them with the costs of installing new windows, therefore making the home more energy efficient and reducing their electricity bill," said Shannon Rolandson, outreach specialist at Community Options.

The assistance program may also help with the costs of furnace and chimney cleaning, emergency assistance and cost-reduction devices.

It is important to remember this program is not only for homeowners, Rolandson said.

"This program not only helps low-income homeowners with energy costs, but renters as well," she said.

#### **Apply for LIHEAP**

LIHEAP eligible members can apply from Oct. 1 to May 31.

"Some individuals can be referred to the program, but anyone is welcomed," Rolandson said. Upon applying for LIHEAP, an outreach specialist will go into your home and assist you in gathering necessary documentation for the service. From there, an application will be sent into the state for review and the results will be provided back within a week or two.

"I wish more people knew the program was available," Rolandson said. "We often hear, 'This won't apply to me' or 'I will just get denied.' But if you need help, please contact us and we will work with you. It doesn't hurt to apply."

"Last year, we processed a total of 548 applications, and 433 were approved for LIHEAP," Roaldson said. If you or someone you know would like to apply, visit your local human service office for more information," Rolandson said.

## RDFC announces 2023 allotment



The Rural Development Finance Corporation (RDFC) is a North Dakota nonprofit finance and development corporation whose member-owners are all the North Dakota electric cooperatives, nine of the North Dakota telecommunications cooperatives and the North Dakota Association of Rural Electric Cooperatives.

The RDFC has approved a 2023 grant allotment of \$3,000 per member-cooperative to be used to support community-owned entities, nonprofits and community-based projects.

Eligible projects include: community-owned businesses (café, grocery store, motel, other); community facilities (ambulance services, fire districts, recreation, hospital/clinic, community center); or community-based projects (school/youth projects, other) that benefit rural areas and lead to community betterment.

Please note RDFC does not provide funds for medical fundraisers or general operating costs.

Matching fund requirements are \$4 of other funds to every \$1 of RDFC funds. The member-cooperative is responsible for verifying the

matching funds. The matching funds DO NOT need to come from the utility cooperative. RDFC will not require documentation.

The minimum grant amount is \$500; the maximum is \$3,000. The limit is \$3,000 per member-cooperative for 2023.
