Meet a “Go-Getter” who is excelling thanks to family and 4-H roots

Livestock judging workouts help students develop life skills

Medora Ellingson has an edge over some of her peers when it comes to judging livestock. A sophomore at Mandan High School, she grew up on the Ellingson Angus Ranch near St. Anthony, where parents Chad and Julie Ellingson produce bulls for commercial bull customers.

Helping the family run a registered Angus operation in the Mor-Gran-Sou Electric Cooperative service area, Medora learned to feed, clean and prepare beef cattle and bulls for sale at an early age.

As a member of the Morton County Go-Getters 4-H Club, Medora knows just what she is looking for during a livestock-judging workout: traits including muscle, capacity and structure.

On Dec. 30, Morton County 4-H organized a Livestock Judging Workout for 4-H members. Eighteen youth from Morton and Oliver Counties attended the workout at Ellingson Angus Ranch, where they evaluated and ranked a “class” of four bulls.

Renae Gress, agriculture and natural resources Extension agent for Morton County, says all the Angus bulls were very good quality; it was up to the students to determine which ones were best and why. In a good-quality bull, a producer wants to see a combination of traits.

The students ranked them from one to four, with one being in the position to outperform the others. Then they wrote a set of reasons based on what they saw, and will present their observations to their coaches at the next meeting. The final part of the workout was the judge

In December, Morton County Extension hosted a livestock-judging workout for 4-H members at Ellingson Angus Ranch near St. Anthony. Students evaluated four bulls and ranked them from one to four based on traits including muscle, volume, capacity and structure. Then they presented their findings to a judge, who asked them to defend their choices with reasons.

asking the students questions about their choices, and they had to give reasons to defend their decisions.

Chad Ellingson breaks down the desired traits and how they help the animal function more productively.

“The [kids] were looking at the muscularity and volume of the bulls. Volume is how deep and capacious they are; a direct correlation to ‘do-ability’ in cattle. If they have more gut capacity, they are better converters of grass on pasture. If they have structural correctness in their feet and legs, they have soundness to get out and graze,” he says.

During the workout, the students also evaluated the bulls for breed character, and have to know a variety of breeds if they want to compete at state and national levels.

Chad says Angus cattle should show very little white. The bulls should look masculine, and females should have a feminine angularity to their heads, which holds a direct correlation to productivity. Females are also evaluated for udder quality and teat placement.

Renae says in addition to learning more about livestock, the judging process helps kids develop communication and public speaking skills that will aid them in any career.

This particular workout is the first one hosted by Morton County 4-H after the holiday break. Chad says his family has hosted it for more than 10 years, and that they are glad to share their heated indoor facility and give the students a warm place to get a hands-on education.

Renae says 4-H members are active throughout the cold-weather months.

The kids in this livestock judging group practice on the weekends in January and February, and are working toward competing in the state contest in March. There, they can earn ribbons and awards based on their performance that day.

Medora’s education in agriculture started at an early age, thanks to her parents and siblings Stetson, Jameson, Sierra and Sheridan. Her knowledge continued to grow through the 4-H program, which she started in kindergarten, thanks to club leaders and peers who serve as mentors. Now she can use her knowledge and experience to help mentor others who are just coming to their first judging workout.

Medora says it’s “pretty cool” that her family hosts this livestock workout every year, and she is proud of the high-quality bulls her family is raising.

“We are helping everyone. We want to help our competitors, too,” she says. “In a few weeks, they [other clubs in other counties] will host a sheep workout for us. We help each other out, and bounce ideas off one another.”

On behalf of Mor-Gran-Sou, we thank Morton County Extension for educating and mentoring these youth in livestock judging and life skills. We also thank the Ellingson family for hosting these youth and being an example of the seventh cooperative principle: concern for community. ■

Mor-Gran-Sou's annual meeting scheduled for July 16, 2021

Are you looking for a way to serve the people of central southwestern North Dakota? Look no further, as Mor-Gran-Sou Electric Cooperative can help you fulfill that desire. Why not serve as a board director for the cooperative? The initial commitment is a three-year term, with provisions in the bylaws limiting a director to serving six consecutive three-year terms, after which time the director is not eligible for another six consecutive three-year terms until one year has elapsed.

At the annual meeting, the following three board positions will be elected:

- The At-Large position presently held by Mark Doll;
- The Morton County position presently held by Kathy Tokach; and
- The Sioux County position presently held by Chad Harrison.

Under the bylaws and due to the use of a mail-in ballot, no nominations are accepted from the floor at the annual meeting. Instead, the bylaws require the board of directors to appoint a Nominating Committee of five to nine members who geographically represent the cooperative. These members will provide a list of qualified and willing candidates to the board for approval and inclusion on the ballot at the board of directors' meeting scheduled for March 24, 2021. This date has been set so there is adequate time for each candidate's biographical information to be included with the notice of meeting sent to the members in June, along with the mail-in ballot for those who are unable to attend the annual meeting in person.

The Nominating Committee has been appointed by the board and met for the first time on Jan. 14. The members of the Nominating Committee include Bryce Allen, New

Salem; Jennifer Bonogofsky, St. Anthony; Jackie Buckley, Mandan; Curtis Feland, Almont; Glenda Gross, Selfridge; Garek Murphy, Fort Yates; Jim Neubauer, Mandan; Donald D. Roth, New Leipzig; and Shari Striegel, Carson.

For a person to be nominated, the member vying for a board seat must submit the completed declaration of candidacy form to Mor-Gran-Sou by 4 p.m. CT (3 p.m. MT) on Thursday, March 11, 2021. The completed form must be mailed to Mor-Gran-Sou Electric Cooperative, Attn: Jackie Miller, P.O. Box 297, Flasher, ND, 58535-0297. If you or someone you know is interested in being nominated, please contact one of the Nominating Committee members or Jackie at Mor-Gran-Sou by calling 800-750-8212, 701-663-0297 or 701-597-3301. You can also email Jackie at jlmler@morgransou.com.

The Nominating Committee members or Jackie can provide you or the potential candidate with the declaration of candidacy form. All qualified and willing candidates who have completed and forwarded the written declaration of candidacy form to the Mor-Gran-Sou office by the March 11 deadline will be included in the list the Nominating Committee will provide to the board. ■

Cooperative offers student scholarships



Mor-Gran-Sou Electric Cooperative takes pride in assisting with the development of rural leadership through our scholarship program. We feel it's important to help finance our local students' educational journeys by offering scholarships to qualifying seniors. With this in mind, we are happy to continue offering our program and supporting graduating seniors in our service area. The applicants must be U.S. citizens and dependents of Mor-Gran-Sou members. All scholarships will be awarded during the 2020-2021 school year.

The co-op will award nine, \$500 scholarships to qualified applicants whose parent(s) or guardian(s) are members of the co-op. School representatives from Elgin-New Leipzig Public School, Flasher Public School, Glen Ullin Public School, Hebron Public School, Mandan Public School, New Salem-Almont Public School, Selfridge Public School, Standing Rock Community School, and Solen Public School will select one graduating senior to receive the funds. Interested in applying? Students should contact their school counselor for deadline information. The schools will then forward each recipient's name to Mor-Gran-Sou.

The co-op will also award one \$500 scholarship to a graduating senior from a school outside of our service area. Please contact our office if interested.

Mor-Gran-Sou Electric continues to award a \$1,000 scholarship sponsored by Basin Electric Power Cooperative.

We award this scholarship to a student already enrolled or planning to enroll in a full-time graduate or undergraduate program. The student must attend an accredited, two-year or four-year college, university or vocational/technical school. Recipients will be chosen on a combination of SAT/ACT scores and overall grade point average; activities, achievements and honors; work experience; a personal statement of career goals; an essay question centered on local cooperatives and how they serve the area; and an appraisal from a high school or college counselor or adviser, instructor or a work supervisor who knows the student well. All post-secondary students who have parents that are members of Mor-Gran-Sou Electric are eligible to apply. Applications are available at area schools, co-op headquarters in Flasher, or online at www.morgransou.com.

Mor-Gran-Sou Electric is awarding one \$500 scholarship sponsored by 3C Construction.

Eligible applicants are high school seniors who are enrolled or planning to enroll in a certified vocational or technical school pursuing a career as a lineworker. The scholarship will be awarded during the 2020-2021 school year. Applications are available at area schools, co-op headquarters in Flasher, or online at www.morgransou.com.

Mor-Gran-Sou is also awarding one \$500 scholarship sponsored by West Dakota Utility Services.


