# 1 More offers lots more

ew name, new owners, new menu; My Place Bar — now known as 1 More Bar & Grill — will continue to be a mainstay of the Flasher community.

Ron Polensky, Flasher resident and Mor-Gran-Sou Electric Cooperative member, managed the bar for 42 years. A family business, his father founded the bar in 1947. Ron and his late wife, Linda, decided to retire and sell the business, and the bar and Highway 21 Café & Steakhouse were listed for sale — for quite some time. Many folks were wondering about the future of the establishment.

Then, Todd Hoff had a lucky catch in the parking lot.

Todd, a Mor-Gran-Sou member who farms north of Flasher along with

his wife, Steph, had always thought owning a bar would be kind of neat — and Ron knew it. Talking together about the possibility one day in the parking lot, Ron threw Todd the keys and said, "Make me an offer." Todd found a business partner and sold some livestock. The rest is history.

Todd and Dennis Berger became the new owners on March 30. Dennis, also a Mor-Gran-Sou member, owns a cement business north of Saint Anthony along with wife, Tammy. Originally from Flasher, Dennis went to school with Todd and they are longtime friends.

Initially, they didn't plan on changing much about the bar. But with the purchase, they learned the name My Place Bar was a corporation, and the sale required a name change. Manager Sharlene Kvarness came up with 1 More: a phrase she hears often while on the job.

Finding good employees to cook and serve is a challenge. **Kristina Perdew**, a Flasher-area resident, cooks for the bar and restaurant, which is now offering noon specials.

Another change came when they bought and installed a char broiler. "We switched to certified Angus brand beef and are serving preseasoned steaks," Todd describes.

After listening to feedback from families including his own, Todd updated the menu. "We added a kids menu, and put together baskets for the middle price range. Everyone seems to be happy with that," he shares.

Cleaning and renovating are also in progress, and Todd says he hopes to make the bar more energy-efficient. At some point, they plan on lowering the ceiling, and adding insulation and sheet rock to retain more heat. They are currently working on updating the restaurant, which they hope to re-open in the fall.

Finding good help is the major challenge. Todd and Dennis agree that they can buy and serve a good-quality steak, but they need good employees to grill and cook, and to serve the patrons. He says they are always looking for trustworthy employees so Todd can keep farming and Dennis

can continue his cement business.

"The bar business has some challenging hours," Dennis adds. "We could always use more help; especially when people want time off."

A lot may have changed, but the same, much-needed service of a banquet hall is still there. They rent it for dinners, dances, funerals, weddings, school events and more, and can cater the events.

There is always activity at 1 More Bar & Grill. Todd says there are still pool and dart leagues and tournaments. In addition, they've added specials including Margarita Mondays from 4 p.m.-7 p.m., half-price appetizers on Wednesdays from 4:30-6 p.m. (dine-in only), and Beer &

Burger Baskets on Thursdays from 5 p.m. to 7 p.m. for \$8.50 (dine-in only).

It's been a couple months now since the change in ownership. With guidance from Ron, who stops by the bar every now and again to see how it's going and if they need help, Todd and Dennis have learned a lot about the business. Dennis says there's a lot more to it than he could have anticipated. It's been a challenge, but so far, Todd says he hasn't regretted making that great catch.

"The community needs and supports this business," he says.
"We've got some stuff to learn yet, but it's been going pretty good." ■

# Mor-Gran-Sou announces candidates seeking board of director positions

# Idle services to be retired

Mor-Gran-Sou Electric Cooperative continues to retire idle services throughout the co-op's service area. What does Mor-Gran-Sou consider to be an idle electrical service? It is a service that is not making any payment to the cooperative, but continues to receive regular maintenance. Your cooperative's procedure is to post a detailed list (to the right) in our communications material to keep members informed of those idle services that will be retired. This is the second notice of this particular group of idle services to be retired.

Prior to this detailed listing,

Mor-Gran-Sou personnel have already contacted, or tried to contact, the property owner and affected property owners based on the information available. If someone comes forward and is willing to pay the line retention fee, we no longer consider it an idle service. However, if no one comes forward, the line is then put on a list and will be retired. The following idle services will be retired at the cooperative's convenience:

# Eckroth earns journeyman status

Inding a lineman to work in a small town — and choose to keep working in that small town — is a challenge many electric cooperatives face.

Mor-Gran-Sou Electric Cooperative is fortunate to have two dedicated men who have made the Flasher area their home and community.

Journeyman Linemen Wayde Eckroth and Joe Michael work out of Flasher headquarters, building and maintaining electrical services in the area. Eckroth, who recently graduated from the Apprenticeship Training and Safety (AT&S) lineworker program administered by the North Dakota Association of Rural Electric Cooperatives, says Flasher has been a great fit.

Hired in January 2012, Eckroth grew up on a farm north of Flasher and says he appreciates the small-town



atmosphere and opportunities. When he's not setting poles and patrolling line for Mor-Gran-Sou, he helps his parents on the family farm, and likes to hunt and fish.

Eckroth finished the books and tests needed to complete the AT&S program in January. As a graduate, he has logged 8,000 hours of supervised training on poles, tower and construction; line hardware

and framing; overhead conductors; tools and equipment; transformers; oil circuit reclosers, regulators and capacitors; metering and instrument transformers; rolling stock; engineering; records; safety meetings; hot-line maintenance; troubleshooting; underground; substations; lighting; and service.

Since graduation, Eckroth has experienced an increase in duties and expectations at Mor-Gran-Sou. He says he feels comfortable with the tasks, thanks to his education and on-the-job training. He's also come to know the co-op's service area better over the years, as well as the member-owners who greet the linemen when they are in the neighborhood, working on lights, locates, meters and substations.

Even though he's completed the AT&S program, Eckroth says learning is lifelong for a lineman. This spring and summer, linemen across the state and nation will be implementing a fall-restraint system that requires linemen to reposition their belts before taking steps up or down the pole.

"We have to relearn how to climb," he says. "It's going to be good; just different. If it saves one person from a fall, it's worth it."

When needed, a Mor-Gran-Sou leadman still travels from Mandan to Flasher to help the two-man crew perform long or intensive jobs. But for the most part, Eckroth and Michael are taking care of the electrical system in the Flasher area, and appreciating what this small town has to offer.

Mor-Gran-Sou thanks these dedicated men for making the Flasher area their home, and congratulates Wayde on earning journeyman status. ■

# Kat Perkius:

## Use social media in a positive way

ocial media helped Kat Perkins rise to the semifinals on season six of The Voice, an American reality television singing competition broadcast on NBC. Perkins, a Scranton native who started singing when she was 3 years old, says 60,000-some followers used sites including Twitter, Facebook, YouTube, Instagram, Snapchat and more to send encouraging messages about performing and winning.

"I felt like the whole state of North Dakota was behind me," she says. "I experienced so much positivity and kindness over social media every single day."

And then, she experienced the other side. Anonymous followers sent her nasty messages about her voice or a performance. One particular follower used Snapchat to send her an image that shocked and disgusted her. The image disappeared in 10 seconds ... but Perkins says it hasn't left her mind.

"I can't unsee that. It didn't go away," she says.

"If you can change somebody's day, do it in a positive way. Instead of sending a nastygram that won't do anybody any good, think about who you are and what you're putting online," she advises. "Someday you'll want to look back on it and say, 'I did alright.' You don't want to look back and think you've made bad decisions. You'll never say you were too nice."

That's the message Perkins brought to Flasher Public School on Tuesday, April 28. She's currently touring the state and nation, in partnership with EduTech on the Positive Social Media Tour, to visit schools and discuss social media with students and give a live performance.

Perkins also touched on the following messages:

**Dream it, do it.** Perkins credits her father with teaching her that she can do whatever she wants and loves to do — but she has to work hard to achieve that dream.

Be brave. Perkins has been singing in front of people since she was a toddler. But to sing in front of 15 million people every week while on The Voice? "I wanted to be the best I could possibly be. I wanted to compete. I wanted to be a top contender," she says. "That took a lot of bravery."

Work hard. Perkins has experienced many bumps in the road during her career. She says she's experienced success because she's worked really hard, loves what she does, and has people who support her. She says her work ethic comes from her hometown and the people who live there.

**Be nice.** Adam Levine, Perkins' coach while on The Voice, always says please and thank you. Perkins reveals he was genuinely kind, and one of the nicest people she's met. He told her he's successful because he gives, so he gets a lot in return.

**Try music.** Perkins encouraged the kids to sing songs or learn to play an instrument. She said music can teach discipline and hard work, and a special song can be therapeutic.

Nancy Malm, Flasher Public School Title 1 teacher, says the discussion and performance brought excitement to the school and its students. "It was something fun and different," she says. While the teachers have talked with students



about social media and safety, Malm says she felt the students were more receptive to hearing the message from an area celebrity.

Perkins' appearance was part of Flasher's annual Family Fun Night. She also spoke and performed in Elgin on April 29; students attended from Elgin, Carson and Mott-Regent. ■
