Ag Day on Thursday, March 19 at Open Road Honda in Mandan. Ag days is held on the third Thursday of March every year during national Ag Week.

This year kids toured around 25 booths, touching, feeling, hearing, seeing and tasting a variety of things related to agriculture, to help them better understand where their food comes from and how it gets from the farmer's field to their table. "With fewer and fewer kids having a connection to a farm through relatives and friends, we are seeing a disconnect as to how kids view their food and farming," says Nathan Boehm, vice president of the Morton County Farm Bureau. "Our goal is to let young people and kids know the connection of farming and the food they eat."

Kids of all ages were encouraged to attend Ag Day, but the focus is on preschool through secondgrade students. "The last six years, we averaged between 2,500 and 3,500 kids, and 500 to 1,000 adults at this oneday event, which is free to the

public," Boehm says.

Highlights included touching a variety of large and small animals, learning how sheep are sheared, and watching a farm safety puppet show put on by the Mandan FFA chapter.

Mor-Gran-Sou Electric Cooperative also had a booth to teach electrical safety around the farm. Jackie Miller, chief of staff and manager of member services, and Julie Armijo, member services clerk, dressed kids in rubber sleeves and safety glasses, so they learned how personal protective gear keeps linemen safe when working around power lines. The kids also received stickers and coloring materials with messages about electrical safety, and watched a safety video. Armijo said the event was a great way for Mor-Gran-Sou, as a Touchstone Energy® cooperative, to show its commitment to community by teaching children about the importance of electrical safety.

The annual event is planned by the Morton County Farm Bureau board of directors. Several sponsors help make the event a success by donating panels and wood shavings for the livestock, and sponsoring a noon lunch for workers and people who work the booths. Boehm thanked Dusty and Annette Caldwell, the owners of Open Road Honda, who have offered the use of their building at no charge for the last five years. "They are great community leaders who understand the importance of agriculture and our community," he commends. The location for next year's event has yet to be determined.

Boehm says the amount of positive feedback received by the Farm Bureau is "unbelievable," and that they are always seeking feedback to improve the event for the coming year.

Mor-Gran-Sou announces candidates seeking board of director positions

he pursuit to earn a board seat begins for six Mor-Gran-Sou Electric Cooperative members vying for one of three board director positions up for re-election in July. In 2015, the three board positions sought include: the At-Large position, one for the Morton County position, and one for the Sioux County position.

The board of directors set March 5 as the deadline for receiving members' completed declaration of candidacy forms. The Nominating Committee met for a final time on March 10. At that meeting, the committee declared that the candidates' names they received be forwarded to the board of directors for approval. Upon confirmation of eligibility at its regular board meeting on March 25, the Mor-Gran-Sou board of directors approved the following list of candidates:
