Clint Begger accepts position with Vigilante

There are 833 distribution cooperatives across the United States, and the employees who are the process behind the power are often such a tightknit group, their co-workers become like family. If you are a lineman, you are what we call a brother's keeper — always looking out for the safety of yourself and others while on the job.

There are lots of opportunities within the electric cooperative network, but at the end of the day, there is only one true family. Clint Begger, lead man with Mor-Gran-Sou Electric Cooperative in Mandan, is moving with his wife, Jada, and their three children, to southwest Montana to be closer to their families. His last day with Mor-Gran-Sou was March 23.

On April 2, Clint met his new brother's keepers at Vigilante Electric Cooperative. With headquarters in Dillon and service centers in Townsend and Whitehall, Vigilante provides electric service to more than 10,150 meters in some of nature's most beautiful (and challenging) places, including mountains and lakes.

During his interview with Vigilante, Clint says he talked about some of his restoration experiences during the snow and ice storms that devastated Mor-Gran-Sou's power system in 2010. He was surprised to learn that Vigilante hasn't lost one pole due to ice freezing on the power lines — likely because the area doesn't get the strong winds that we do.

A native of Wibaux, Mont., Clint went to college in Powell, Wyo., and earned a business degree in agriculture, along with a farrier certificate. After ranching and competing in rodeos for some time, he was looking for a change. His brother, who works for Montana-Dakota Utilities, recommended the utility industry.

Clint moved to North Dakota and enrolled in the Bismarck State College lineworker program, where he learned the basics of the trade. After he graduated, he applied with Mor-Gran-Sou as summer help in 2003. He says he felt lucky when the co-op kept him on full time.

Clint graduated from the Apprenticeship Training and Safety program in 2006 and earned journeyman lineman status. He was promoted to lead man in April 2012, and worked for Mor-Gran-Sou for 15 years.

"It's tough to leave all this behind; trust me," he says. "It's been a lot of sleepless nights for Jada and I, talking this through. Back in 2002 when I went into the lineman program, this was our goal — to move out to western Montana somewhere. I didn't know it was going to take 15 years for that to happen."

Clint will work out of the Townsend outpost with two men. While he'll help build and maintain Vigilante's distribution system, he'll have additional duties that may require him to sharpen his domestic skills.

"Their foreman told me they do everything from the line work to the staking sheets to mopping the floor to cleaning the toilet," he says with a laugh. "The three of us are it for all of the duties."

Outside of work, Clint's first year will be busy finding or building a home that has land to accommodate the family's horses. Clint and Jada compete in team-roping, and their daughter, Ella, is involved in junior high rodeo. Clint is the current president of the Mandan Horse and Saddle Club, and the Beggers are members of New Salem Saddle Club. Their children are involved in various sports and activities. The family's move is a collective loss for this community, and a gain for another.

Change is hard, but it can be good. Clint says the job opportunity came at a good time, even if it was 15 years later than expected. The Beggers had outgrown their home and were looking at options. Their oldest daughter hasn't yet started middle school. While they are wellconnected to this cooperative and community, Clint says it's the right time to fulfill that initial goal of moving to Montana. That doesn't make it easy.

From the management to the linemen to the support staff in the office, Clint has only positive words to say about the people he worked with at Mor-Gran-Sou.

"They've all been great. I can count on them," he says. "Hopefully I can trust the new guys as much as I trust these guys."

It's especially hard to leave a good boss. Clint says Manager of Operations Randy Ressler is thoughtful, respectful and smart, and he's the kind of boss every lineman wants to work for because he always has their backs.

"He knows how to treat people," he says. "I really respect him, and that's what makes it so tough."

During his last week of work, Clint said he appreciated that Mor-Gran-Sou had given him a good job for the last 15 years, and that he's been treated well.

Clint has treated our members well, too. Over the years, he's done safety demonstrations for area children; volunteered to help restore

electric service at neighboring cooperatives to reduce outage times; and taught apprentice linemen the safety, skills, and value of being a brother's keeper.

Thanks, Clint. You'll be missed. ■

Idle services to be retired

or-Gran-Sou Electric Cooperative continues to retire idle services throughout the co-op's service area. What does Mor-Gran-Sou consider to be an idle electrical service?

It is a service that is not making any payment to the cooperative, but continues to receive regular maintenance. Your cooperative's procedure is to post a detailed list (shown below) in our communications material to keep members informed of those idle services that will be retired. This is the second notice of this particular group of idle services to be retired.

Prior to this detailed listing, Mor-Gran-Sou personnel have already contacted, or tried to contact, the property owner and affected property owners based on the information available. If someone comes forward and is willing to pay the line retention fee, we no longer consider it an idle service. However, if no one comes forward, the line is then put on a list and will be retired. The following idle services will be retired at the cooperative's convenience:

Hundreds of North Dakotans have

discovered treasures during the Highway 21 Treasure Hunt, scheduled for June 15-16.

"What started as a rather simple idea 17 years ago has grown to an event that attracts visitors from across the state, out of state and Canada," said Luann Dart, the event's coordinator.

During the event, communities along Highway 21 in southwestern North Dakota host citywide rummage sales including Flasher, Carson, Heil, Elgin, New Leipzig, Mott, Regent and New England. There will be approximately 100 rummage sales along the route. Rural residents host sales, too, so watch for signs along the route for additional sales.

Listings for each community's sales will be available at certain locations in that community, such as restaurants or gas stations. Listings are also posted on the Highway 21 Treasure Hunt Facebook page or at www. elginnorthdakota.com just prior to the sale.

"Hundreds of people have discovered the treasures along Highway 21 during the annual Highway 21 Treasure Hunt," Dart said. "We encourage everyone to plan to attend the 2018 event."

Although in its infancy stage, Mor-Gran-Sou Electric Cooperative is now offering Operation Round Up to its members. Operation Round Up is a program in which Mor-Gran-Sou members can voluntarily choose to round up their monthly utility bills to the next dollar and donate their pennies to the newly formed Mor-Gran-Sou Charitable Foundation, Inc.

The Foundation Board, who are also Mor-Gran-Sou Electric Cooperative members, include: Linda Mindt, Linda Urlacher, Serena Weinhandl, Chad Wild and Cherie Zenker. They will meet throughout the year and disburse funds in the form of grants to non-profit corporations, organizations or agencies. All of the money raised by members stays in their local communities. Mor-Gran-Sou is making this request on behalf of the Mor-Gran-Sou Charitable Foundation, and all funds gathered will be donated to the Mor-Gran-Sou Charitable Foundation, Inc., which will be the sole beneficiary of the funds. The board will disburse the funds equitably throughout the Mor-Gran-Sou service area as practical.

On average, participating members donate about \$6 a year. For example, if a member wishes to participate in Operation Round Up and his or her monthly electric bill is \$89.64, the amount would be "rounded up" to the next whole dollar, \$90. In this example, the member would contribute an extra 36 cents to Operation Round Up. The most a member would ever contribute a month is 99 cents. The donation will be tax-deductible, and members who participate will receive a summary on their last billing statement of the year.

Mor-Gran-Sou does not receive monetary or in-kind reimbursement from the Operation Round Up Charitable Foundation. All rounded-up funds flow directly into the Mor-Gran-Sou Charitable Foundation, Inc., and are overseen by the board of directors. Mor-Gran-Sou personnel will administer the program as a complimentary service to the foundation.

We understand it will take some time to grow this charitable program, and we are excited to get started.
